# Kandoolu Terms of Service

Welcome to Kandoolu, a product of OnHand Schools, Inc. The Kandoolu website and all products and services of OnHand School are provided subject to the terms set forth herein. If you visit the site, you agree to be bound to these terms.

OnHand Schools reserves the right to make changes at any time to these Terms of Service. Any modifications to the Terms of Service will be effective upon posting.
